Words spoken by President Reagan in 1987 at the Brandenburg Gate. Stalin's paranoia, along with NATO intransigence towards Russia, caused the Soviet Union to walled-off East from West Germany for almost 40 years. Then, because Russia wanted detente with the West, as a trading partner, not an adversary—the wall came down,

Gorbachev, even without Stalin's paranoia, didn't change things. The US needed an enemy to insure military industrial complex hegemony. Russia was the forever enemy.

It's still that way. In fact, today could be the most dangerous day in human history. Russia is on full nuclear alert, such that 1 simple message from the Kremlin launches nuclear missiles. Just as in 2022, when Russia warned that if its security concerns were not addressed (a non-NATO, neutral, de-nazified Ukraine), they would have to take action. Assuming Russia was bluffing then, like now, we forget Putin doesn't bluff.

It took most of 3 years for a plurality of Americans to tire of the carnage in Ukraine, yet few understand that US/Britain, with no concern for Ukrainians, offered-up a million Ukrainians to be slaughtered on behalf of the military industrial complex, while blaming Russia. That's another article. For today I'm addressing another wall—within America.

This *wall of woke*, is what the left lean on for support as they subvert the Constitution. The resurgence of Trump and the denigration of democrats have changed the *song of the sirens* (Homer), from a chorus of *equity—to opportunity*, a backlash against woke—across the nation. If used judiciously—a backlash that could save the republic.

Begin in San Francisco (the epicenter of woke), where the mayor and district attorneys have been turned away by voters in favor of more centrist candidates. Voter's reasons (63%), are rising crime and homelessness. Newsom rushed police into defunded districts to thwart recalls. But woke is crumbling—even dems have had enough.

The fix for what is wrong with America is neither found specifically in cutting the size/ spending of government, ending the war in Ukraine, nor pacifying the Middle East. The fix for our ills is to enforce upon the Legislature, the Courts, and the Executive, a return to constitutional mandates/duty. As an agenda, this could return us to the republic.

Making law and funding implementation of law is a constitutional mandate for the legislature. But, as government grew, the legislature passed along the making of policy (law), to regulatory agencies. Regulators, in place, long after members of Congress depart, not only set policy, but under the Chevron Doctrine, since 1984, set themselves

up as policy arbiters/enforcement, such that courts became subservient to regulators.

That's your deep (forever) state, making the rules and enforcing the rules. Think on the tyranny the FDC, CDC, NIH inflicted on Americans, as regulators, profiting from patents, and enforcement—almost bringing us internment camps for the unvaccinated.

During 18,000 Chevron citations, over 40 years, the courts were hamstrung to judge the constitutionality of policy, The Supreme Court overturned Chevron in 2022. Now, pushback against that finding does not cite the Constitution, instead business interests.

The judicial power of the United States shall be vested in one Supreme court, and in such inferior courts as the Congress shall from time to time ordain and establish. Supreme is simply that—the only constitutional court and the final arbiter of US justice.

Consider federal law as opposed to constitutional interpretation. The Supreme Court is seldom called upon to interpret the Constitution. Instead, Congress makes a law that the Supreme Court measures in terms of its constitutionality. But with the Chevron Doctrine in place, without specific policy expertise, courts deferred/avoided the issue.

Using stare decisis (let the decision stand), the court absolved itself of having to test for constitutionality by handing decision-making to regulators. This subverted the constitutional mandate for legislators to pass laws and the court to judge constitutionality.

This process made possible the horror of Ukraine. Without a declaration of war (duty of Congress), the Executive wages full scale discretionary wars, that under the Constitution would be subject to impeachment/trial as acts of treason against the republic.

Now it's even worse—a lame duck presidency with 60 days left, goes against its own 4 year policy, in support of Israel (with no treaty or alliance), to use US long-range missiles, needing US agents to launch, against nuclear Russia—without a war declaration.

The insanity is such that we don't even know who's at decision-making levers. President Biden, demented, is controlled by a cabal of actors in a back room. \$175B to UKR by executive pen for what outcome? Support for war machine—hamstringing Trump.

2 things are in play: Will President Trump focus on getting the US back in step with the Constitution, and, is there the required Supreme Court patriotism to do its duty?

Each regulatory agency has to return to a function of carrying out explicit directions from Congress—without policy-making function on its own. They do the bidding of the citizens through their legislators, subservient to Congress and the Supreme Court.

With only 1 constitutional court (Supreme Court), it's of utmost importance that persons nominated to that court be constitutional scholars (last nominee was chosen, based on race/gender). That justices understand constitutional mandates is imperative.

To make it such that President Trump sees inauguration, with 4 years to steer the nation in the direction of constitutionality, will require some good fortune. With what the Biden Administration is doing, 1 bridge too far will initiate a Russian nuclear response.

Russia has signaled with a medium range ICBM/conventional payload (outlawed until Trump ended the medium-range treaty). Russia is ready to retaliate for long-range missiles launched into Russia, with nuclear evisceration of a US staging site in Poland.

There are global implications from Trump administration policies (next article), but those dangers pale in comparison to the madness coming from the left. Dem state officials count ballots in defiance of state supreme court rulings. Left appointed generals (maybe 10X the number needed), announce publicly—the US is ready for nuclear war.
