A working analogy for our political climate is TR (Teddy Roosevelt), who became president in 1904. By 1908 he wanted out and handed it over to his friend, William Taft, who with TR's backing won the 1908 election—which resulted in ending their friendship.

TR, by force of his huge personality, took on monied interests in support of the little guy. But, as the head of the world's biggest economy, TR also wanted the US to flex its military muscle. Taft, wanted to reel-back the presidency to its Constitutional mandates.

Big personalities don't hold back for long, and the Republican Convention of 1912, found TR, *duking it out* with Taft for the nomination. TR had the people but Taft had the party—which gave him the nomination. TR, of course, could not abide that, so he formed the *Bull Moose* party, garnering more votes than Taft, splitting the vote, and giving us a little known, Woodrow Wilson, who would reek havoc on the nation and world.

Now we have our big personally, Trump, back for a 2nd term. Trump is a personality as large as TR—but maybe not as intelligent. As an example: Trump has warned the BRICS that ceasing to use the dollar would bring down on them the wrath of god (small caps). Doesn't Trump (or any of the fools surrounding him), understand that BRICS is nothing more than the result of US weaponizing the dollar and de-banking the world?

This would pit Trump against those reaping LNG profits, while increasing US control over Europe—for all its energy supply/needs. Maybe the *art of the deal* could strike a bargain with LNG profiteers—at the same time set conditions for peace negotiations?

Constitutionally, we have no business in Ukraine—or funding Netanyahu. Big American personalities have taken us far away from constitutional mandates. The defining characteristic, the fulcrum that balances what it to be an American patriot, is adherence

to the Constitution/Bill of Rights. Few American elites are patriots, but an abundance of big personalities make their way into the halls of Congress and into the presidency.

Consider the last several presidents—measured against constitutionality. Start with Clinton who allegedly bombed a foreign nation because of a semen stain on a dress. Then came anti-American, Obama, selling-out the Constitution to a pack of globalists.

Next, Trump, who got rid of the INF treaty (which may culminate in the end of human history). Trump's big personality is getting ready to re-occupy the Oval Office which is hopefully a better result than the Obama tyranny selling out the US to WEF globalism.

So, replete with Trump danger—here we go. Unconstitutional American institutions include the FBI (the legacy of a J Edgar traitor to American values), Homeland Security, a useless-counterfeit appendage of 9-11/Dick Cheney.
