## *Sowing Seeds On Scorched Earth*

The global economy could have been saved in 2007 had we allowed the markets to do their job and burn through the excess. But that didn't happen. And, there could have been a 2 state solution for Palestine, but now it's too late for what is no longer possible.

This article is not about Palestine, but '2 state solution' is an apt analogy for a pre-eminent political/economic question: are we fated for a unipolar or multipolar world?

A world functioning as both unipolar/multipolar, at the same time, is not possible. As with gold, priced at fair value in 1 part of the world, while its price is suppressed in another part of the world, the condition exists, only seemingly, until the battle over the true price of gold is settled. Similarly with unipolar/multipolar, in the end, 1 of the 2 wins out.

Sadly, since WW2, US European allies have been closely monitored to ascertain no representative democracy takes hold on the Iberian Peninsula. Instead, Europe was molded as a colony of US interests, over which appointees and NATO—would govern.

Germany, the beneficiary of cheap Russian energy, became the engine for Europe, while the US disallowed any enduring alliance between EU/Russia. This was accomplished through original EU design, trade sanctions, and destruction of NordStream.

Now that the US has played its energy card, having accomplished destruction of NS, and its NATO card (Ukraine), all the chips are moved to the center of the table, on a bet the US will again find a way to sustain both its unipolarity and European feudalism.

But this will not happen. At best, were the US to prevail, it would inherit a hollowed-out Europe—without fine German toolmaking that drove the entire continental economy. Without Russian energy, German industry faces a choice: shut-down or move out. The US plan had German manufacturing relocating to the US—adding to US dominance. But German manufacturing cannot relocate to the US because US cost of living /regulation—disallows profit. Leaving only default choice of industrial relocation to Asia.

This US tactic comes with a couple of unanticipated consequences. This is not the WEF/Schwab vision of 2030. Instead, 2030 is held in abeyance until the outcome of a war to the death between unipolarity/multipolarity is decided in economic bloodbath.

At best, the US gets get an unproductive Europe, overrun with low-skilled migrants, a Europe where German and high-skilled EU workforce are forced to relocate because there will not be jobs for highly-skilled workers. Assuming the US prevails in its intended subjugation of Europe—what will be left is a non-productive, racially-turmoiled EU.

US strategy to divide and conquer Europe is motivated by evil intent, but the tactics, and resultant horror are far too stupid to share the throne with evil. When weighing evil and stupid, we ought not ascribe to malice that which can be attributed to ignorance.

The sad truth is that, Europe we knew, for now, maybe far into the future—is done. A war is being fought between the US (allied with Britain, Australia etcetera, maybe Israel—if it sees gain for itself), against the BRICS and nations aspiring to join BRICS, who've been willing to bring the US into the club, but that window may now be closed.

I listened to Catherine Austin Fitts make some solid geo-political points: *Multiple global organizations work together to achieve total control*. That explains why global elites are seen as working together—rather than a many-headed hydra attached to the same body. The war to control humanity is being conducted by a varied host of tyrants.

In my view, what Catherine gets wrong is her doubt that multipolarity will win out. She cites the US fleet in the Middle East as positioned to threaten Saudi Arabia dislodging from a US sphere of influence to align with BRICS, when, in fact, the rest of the world sees only a 'bathtub Navy' of a bankrupt empire—diminished as a global player.

I'm betting that 2024, because of a scheduled US election, will be the year of decision. The year of the undoing—the year of the 'great awaking' or 'great reset'. The year when 2 armies, 1 intent on global control, and another, the army of 'pushback', with its streaming standards of liberty and justice (patriots of 'inalienable rights'), join in battle at redoubts/disputed barricades—in a fight to the death (sorry for a bit of hyperbole).

Multiple organizations are working together to achieve total control—that's why they all seem to be working together. With so much a stake, will there be an election? Will elites, fearing outcomes of an election opt for a diversion through world war/cyber war?

Or, without opting for war, might elites get war anyway? Since we have already declared economic war on the world, at some point will BRICS see it for what it is and default on dollar-denominated debt? When Russian Forex is given over to Ukraine as a gift from a bankrupt West, will the US become an economic pariah—for all to see?

Back home, attacks on the Bill of Rights, and the resultant, degenerate misery associated with that attack, is but an axiomatic result, attributable to abandoning the gold standard (sound money). Viewed in historical terms, the adventurism that was Vietnam, along with an accompanying welfare state, set in motion the future we face today.

So, what might we look forward to in 2024? I'm not even going to guess but the prospects are titillating. Whatever the unfolding, it will be devastating for the US, and, if the US refuses to accept a low-grade devastation, horror will be wrought on the world.

For the age old maxim: *If you buy 1 load of shit, you'll buy another*, 2024 has its best chance to play-out, across the board. Will the non-representative EU opt to follow the US down a road to perdition? Will a congressional vote that disallows the president to opt out of NATO matter, when NATO collapses under weight of ineptitude/bankruptcy?

Will Admiral Kirby find a way to spin the loss of Odessa, and unconditional surrender of Ukraine to Russia, as just another bump along the road on the path to total victory? Will 'excess deaths' and trillion dollar lawsuits, bankrupting Pfizer/Moderna take the wind out of WHO sails, and plans to enslave a world from fear of coming viral horror?

Pushback against the elites is growing, with more of us willing to do what needs to be done. Without attaining feudal control, elites, in the end, will prove feckless cowards running with stolen loot—to be hunted down. In the end they lose. Happy New Year!
