Science is not a noun—it's a verb. Science can only be identified as a 'noun' when it is used to describe the 'verb' that it is. There is no 'the science'. Someone can only be termed 'a scientist' when involved in experimentation that leads to scientific discovery.

Corporate-controlled physicians are forced to follow the dictates of lawyers and non-physician bureaucrats. And, just as the number of government employees expands at 3 times the rate of population growth (at some time everyone will work for the government?), the number of independent doctors is inverse to a corporate medical takeover.

Corporate-funded doctors are neither independent nor do they (as shown during Covid), work for patient's best interest.
