What Do We Do About Feds and States Interfering In Our Rights?

'Big government' proponent', Alexander Hamilton, agreed with 'government of the people' advocate, Thomas Jefferson, that left to its own devices, over time, bureaucratic forces would overwhelm the people, and the only way to impede that phenomena was for each generation of Americans to wage non-violent revolution against governments.

As with a Fed, 'beating a path of banal stupidity' that needed to be stopped decades ago, which necessarily ends in economic collapse, it is now apparent that constitutional 'checks and balances' authored by the founders to protect the republic have been marginalized, and, at the behest of despots are perilously close to becoming 'null and void'.

As 2022 comes to a close—where are we? Our governments (some state and for certain federal), are no longer constitutional. In an environment where the FBI dismisses 'treasonous influence' over American platforms of communication (for at least the 2020 and 2022 elections), as something they do all the time—this is 'Watergate X100'.

The most threatening aspect of a 'glad-handing', FBI dismissal for what they did, is the likelihood they get away with it. If this criminality is pushed aside, it's because FBI election interference elected candidates who will now 'immunize' the FBI's conduct.

What are the legal consequences of 'election interference' on the part of federal agencies? Biden is not the president, nor is Trump. The presidential election of 2020 is 'voided', requiring a new election. Congressional elections are 'voided' over FBI interference. 'Elected' judges cannot rule on election fraud or 'find' on new laws passed by 'participants in the corruption'. The United States is without representative governance.

Anyone elected with vote totals that were close, must assume federal interference, and, since there is no way to determine if that interference was sufficient to sway the results, there is no remedy that doesn't involve bringing the republic to a standstill.

Government corruption in America is manifold and everywhere. Now that government agencies are caught committing a Constitutional 'high crime', yet dismiss it with 'heedless indifference, what is the recourse when 'participants in the corruption' refuse to uphold a 'constitutional oath'? As mandated US militia, do we have recourse other than the 2nd Amendment, combined with mandates for citizens to 'enforce US laws'?

We do, and that's where we go—1st. Our court of last resort, the Supreme Court, not elected, has the power to overturn any law and lay blame at the feet of anyone. Some of you, having long given up on 'institutional remedies' will find no merit in using the

courts, which precludes you making a donation to ICAN that won the judgement requiring Pfizer (FDA) to release all documents in months—not over 76 years. They are also behind suits over 'vaccine' mandates', masks on planes, religious exemptions for health worker/military—and are presently suing government regulators to exempt kids.

They have power but not constitutional legal power—and down-deep they know it. No matter our overall view of the courts and Congress, there are some really good people out there doing God's work. For sure, before its over we may have to fight dirty and to the death for our rights, but I'm betting we won't have to. In the same way tyrannical school boards are brought down, judicially, we go after unjust laws until Klaus Schwab gives up, takes down his web site and moves to a jurisdiction without an accommodative US extradition treaty.

The powers that be are losing ground in the courts—but the outcome is still 'up for grabs'. Where we are at great risk is over a proposed WHO treaty that would effectively take over our nation and our bodies. But, unlike what is being reported, this is not a 'treaty addendum'—this is a 'new treaty' requiring 75% of the Senate to vote for it.

Many judges keep their oath to the Constitution, ruling in favor of the people. But, as with ICAN lawsuits, when they get Obama-appointed judges, the case is not allowed to proceed. So they refile and hope to be judged by an 'American'. With 'findings/rulings' from 'fair-minded' judges, institutional facades are beginning to crack and crumble.

What rulings can we look forward to in 2023? Illegal collusion with federal agencies causes the social platforms to lose any immunity, allowing courts to enforce the 1st Amendment on them—putting an end to indiscriminate and all political censorship.

Medical companies, since Reagan (with an intention to protect Americans from pandemic), have been given immunity for 'vaccine' injury. But the government, assuming that liability, is not immune. With many agreement provisions between Pharma and government not being adhered to, government has that liability and is subject to suit.
