*What Role Do FDA/CDC/NIH/WHO Play In Our Lives?*

My original title asked if health regulators are criminal conspiracies—but Google would have made spam of my email (still might). Why are so many doctors on-board with the 'vaccines', for themselves and their patients? Doctors are not appraised of 'vaccine adverse reactions' because drug manufacturers and health regulators hold back the data from practicing doctors. My own family is subject to 'unaware physician' phenomena.

For doctors and the public, Pharma dictates that placing blame for 'adverse reactions' and 'excess mortality' on 'vaccines' is an 'impossibility', creating conditions where the public and few researchers bother to delve into it. This brings to mind the operating premise for Arthur Conan Doyle's, Sherlock Holmes (a forensic doctor): "When you have eliminated the *impossible*, whatever remains, however *improbable*, must be true."

So why is Pharma's dictate of 'impossible' not being eliminated? Without scrutinizing the impossible there is no 'informed consent' because we lack the means to make judgments about what we allow into our bodies. This is a most important 'individual freedom' that came as a result of the Nuremberg trials—'inviolable informed consent'.

Why is the necessity for 'informed consent' being overrun? Pharma, more than the Pentagon, the Fed, or the Oval Office, has taken control of our lives. Regulators, funded by Pharma have become 'cheerleaders'. Congress and the president do not get elected without the backing of Pharma. So, what is at the root of this phenomena?

Profit—there have been many bad 'vaccines' withdrawn after a small number of serious side effects. But there has never in the history of medicine been a 'cash cow' of this magnitude—of which shareholders are well-aware. The profit-makers see this 'gift from the gods', as getting in on Bitcoin for a dime, and nothing is going to jeopardize it.

Especially the facts: 85% of Britain's NHS budget comes from Pharma where it is reported that 7500 patients over 80 need to be 'vaccinated', before 1 is saved from the virus. How many persons, especially young persons or parents of children would pursue the inoculations if they were privy to this information? And, US health regulators no longer do their own testing—it is outsourced. Do regulators have any visible function?

Unfortunately they do, as 'yes-men' for drug lords, regulators push-back, censure, and when necessary, un-license physicians who raise voices against untested protocols. At 12:01 today, there came a new law to California wherein doctors will face discipline for spreading so-called misinformation/disinformation about COVID-19—including

information about vaccine effectiveness and other treatments. The charge against them: unprofessional conduct. These doctors will, in many cases, have been ahead of the curve—when a year later Pharma's narrative lies in ruins—along with doctor's lives.

This brings to mind the most 'unscientific' utterance of the coronavirus era—'the science'. What Fauci and Co. mean by 'the science' is 'the unquestionable'—that which is beyond question—which is anything they say it is. They know well there is nothing that can be called 'the science' because nothing in science is beyond question. This is about surety—surety that their control is beyond critique—even even skepticism.

For the Pharma elite, everything depends on them being able to defend that position, where the main tool (beyond billions in taxpayer-funded propaganda), is fear. Early in the pandemic fear convinced Americans hospitalization was 1 in 2—it was 1%.

Trials were done without control groups, amidst campaigns to get everyone 'vaccinated' because, with everyone 'vaccinated', there is no control group. Excess deaths, brain fog, infertility, heart failure, and blood-clots become the 'unexplained new normal'.

That was their hope, but now comes good, peer-reviewed research, and levels of unanticipated 'excess deaths'—not caused by the virus. How long will the mainstream be able to avoid research showing 'blood clots' to be bio-synthetic structures (sounds worse than blood clots). How long before Pharma has to account for DARPA's purported definition of the virus as 'a bio-hybrid micro robot'—nobody wants that in their blood.

How long before parents realize that the whole thing is now purportedly subject to military protocol and when they take their kids in for scheduled jabs, those 'vaccines' are allegedly not subject to earlier production quality, rendering all 'vaccines' emergency, without rigorous manufacturing standards—as is the case with mRNA jabs.
